ORDINANCE 2022 –15

AMENDING ORDINANCE ESTABLISHING THE  
COMPENSATION TO BE PAID TO OFFICIALS AND  
EMPLOYEES OF THE TOWN OF THORNTOWN, INDIANA,  
FOR CALENDAR YEAR 2022

WHEREAS, Indiana Code § 36-5-3-2(b) confers upon the Thorntown Town Council (“Town Council”) the power to provide reasonable compensation for Town of Thorntown (“Town”) employees and elected officers; and

WHEREAS, on \_\_November 15<sup>th</sup>, 2021\_\_, the Town Council adopted Ordinance 2021-16\_\_ An Ordinance Establishing the Compensation to be Paid to Officials and Employees of the Town of Thorntown, Indiana for the Calendar Year 2022; and

WHEREAS, on \_\_April 18, 2022\_\_, the Town Council adopted Ordinance \_2022-6\_ amending Ordinance \_\_2021-16\_\_; and

WHEREAS, the Town Council deems it necessary to further amend Ordinance \_2021-16\_ to reflect changes to Section 3-Utility Compensation pursuant to recommendation of the Thorntown Utility Service Board.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Thorntown in the State of Indiana that the following amendments should be made to Section 3-Utility Compensation of Ordinance \_2021-16\_:

**Section 1 – Amendments**

**Section 3 – Utility Compensation of the 2022 Salary Ordinance \_2021-16\_ shall be repealed and replaced with the following:**

The total compensation to be paid to the only compensated employees from the Electric Utility, Water Utility and Sewer Utility:

Utility Service Board President	\$1,200.00 annual (to be paid quarterly)
Utility Service Board Member (2)	\$1,000.00 annual (to be paid quarterly)
Utility Superintendent	\$30.00 - \$50.00 per hour range, based on a 40-hour work week
Utility Workers #1 and #2	\$20.00 - \$46.00 per hour range, based on a 40-hour work week

Billing Clerk	\$20.00 - \$36.00 per hour range, based on a 40-hour work week
Clerk/Treasurer	\$6,483.09
Weekend Call Duty	\$80.00 - \$120.00 range
Part-time Office Help	\$15.00 - \$20.00 per hour range
Temporary Labor	\$15.00 - \$25.00 per hour range

**Section 2 – Effective Date**

This Ordinance shall take effect upon its adoption.
